**Police Officer Rate: \$75.00 per hour**

**Security Officer Rate: \$38.50 per hour**

**Marked Patrol Unit Fee: \$5.00 for police + \$3.00 for security = \$8.00 per hour**

**Total Hourly Rate (per team): \$121.50 per hour**

#### **Advantages of Hybrid Patrol:**

**Provides Same law enforcement presence while reducing overall costs.**

**Security officers, licensed through both the St. Louis County and St. Louis Metropolitan Police Department, have full power of arrest while on designated posts.**

**This would be structured with the Police officer In command and the Security Officer as His Subordinate Reporting and coordinating under the off duty Police officers Direction.**

**Both the Police Officer and Security Officer will work together, exchanging information and providing backup. To each other.**

#### **Option 2: Dual Police Officer Patrol (Two Off-Duty Officers)**

**This option provides patrol coverage exclusively using off-duty, sworn police officers.**

**Police Officer Rate (per officer): \$75.00 per hour**

**Marked Patrol Unit Fee (per officer): \$5.00 per hour**

**Total Hourly Rate (per team): \$160.00 per hour**
