# Infrastructure Committee Meeting Minutes

July 9, 2025 @ 6PM

### Meeting Opening (5 minutes)

- Ryan made a motion to start the meeting at 6:00pm. Alison seconded.
- Record member attendance – Alison, Meghan, Mark, Ryan, Loren, Joe, Jarred, Brett and Mechelle
- Ryan moved to approve the June minutes with no revisions, Loren seconded

### New Business (50 minutes)

#### Working Group Updates

##### Publicizing Infrastructure and Traffic Calming

- Alison will have a table at the Carondelet Movie Night to share the infrastructure traffic calming plan and answer any questions from the public

##### Traffic Calming Efforts

- Speed hump at the west end of the park was removed to accommodate The Tour of St. Louis Bicycle Races
- A takeaway from the June SBD meeting was that the fire chief would like the speed humps to be clearly identified. Members discussed the possibility of painting the speed humps to coordinate with the designs created by Ten8. Brett and Mark will contact Streets to explore what guidelines may be in place for painting speed humps.
- Brett and Mark will also inquire about guidelines for painting crosswalks.
- The committee will begin looking into the Holly Hills and Leona intersection as our next possible project.

##### Missouri Department of Conservation Grant

- The Beautification Committee is investigating a grant offered by MDC for tree maintenance. Mechelle will inform Beautification that we are interested in further information.

### Guest Speaker

#### Friends of Caradelet Park - Hannah Ehrlich

- Last year, FOCP utilized a matched grant with MDC for invasive species removal.

- These areas need ongoing maintenance to address resprouting for 5 years, in both the spring and the fall
- FOCP is asking if the SBD would be willing to, for lack of a better term, loan FOCP the monies needed to pay for the treatment and be reimbursed by the match grant money.
- Ryan made a motion to investigate the potential to support a neighborhood organization for specific grants like this one from MDC without any financial amount associated with it. Alison seconded the motion.
- The committee unanimously agreed

**Public Comment (0 minutes)**
