

Statistics: Please note as of 2021 UCR SRS data is no longer available as FBI crime data regulations dictate the switch to UCR NIBRS. These are federal definitional changes so that data can be comparable across the united states. Because these definitions and standards are new and allow for a single crime to be counted across multiple categories, this document used data from the SLMPD Records Management System (RMS), and subscribes to hierarchical rules. Counting each crime as a singular incident as written, and counting the highest NIBRS order crime only once. These are subject to change as they are reviewed by quality control and are considered "live" numbers. While they are comparable to each other, they are not comparable to other data sources, such as UCR or NIBRS crime categories/definitions/counting standards.




Shift, Time, and Day of Week Analysis






